Background

The Royal Borough of Kensington and Chelsea delivers a variety of toilet provision across the borough. Although these services are non-statutory, the Council understands the importance of providing toilet facilities. However, the Council also has an obligation to spend public money wisely and ensure value for money.

Of the facilities provided across the borough, some are provided via contractual arrangements with a supplier. These automated public conveniences (APC) come with hire and maintenance charges payable to the supplier.

A number of these APCs are not value for money and the Council is proposing that these units should be closed.

Having reviewed the cost per use of these APCs, three have been identified as not being value for money and the Council is proposing that these units should be closed.

- Gloucester Road Outside Boots at 128 Gloucester Road, near the junction with Cromwell Road.
- **South Kensington** Outside the south entrance/exit of South Kensington Tube Station in the open piazza area. Officially it is located on Old Brompton Road.
- **Sloane Square** Opposite Sloane Square Tube Station, at the junction of Sloane Square and Holbein Place.

Consultation Methodology

The original review of toilet facilities was conducted before the Covid-19 pandemic. A subsequent review has been conducted post pandemic. The Council's Executive Management Team have taken the decision to close three APCs based on the review. The Council are seeking the views of residents and stakeholders on the proposed closures of the three APCs.

Report

A total of 10 surveys were returned by the deadline. This report contains data tables and comments detailing the responses to the survey questions. Percentage figures have been removed from the data tables in this document as these figures can be misleading due to the low number of responses.
