BASIL STREET – EXPERIMENTAL REPLACEMENT OF WAITING RESTRICTIONS WITH A RESIDENTS' PARKING PLACE

The Kensington and Chelsea (Charged-For Parking Places) (Amendment No. 12) Experimental Order 2020
The Kensington and Chelsea (Free Parking Places, Loading Bays and Waiting, Loading and Stopping Restrictions) (Amendment No. 12) Experimental Traffic Order 2020

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea on 7th April 2020 made the above-mentioned Orders under sections 9 and 10 of the Road Traffic Regulation Act 1984, as amended. The Orders will come into operation on 15th April 2020 and continue in force for up to 18 months.
2. The general effect of the Orders will be on an experimental basis, on the north-west side of Basil Street, opposite No. 31 Basil Street, to remove 14 metres of 'at any time' waiting restrictions and replace them with a residents' parking place that would operate 8.30am-10pm on Mondays to Fridays, 8.30am-6.30pm on Saturdays and 1pm-5pm on Sundays (8.30am-6.30pm on Sundays that are a 'special occasion' as defined by the Council).
3. The Orders provides that in pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Director for Transport and Highways at The Royal Borough of Kensington and Chelsea Council, or some person authorised by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Orders extends, modify or suspend the Orders or any provision thereof.

5. A copy of the Orders and other documents giving more detailed particulars of the Orders can be inspected at Council Offices, 37 Pembroke Road, London W8 6PW during normal office hours on Mondays to Fridays inclusive or may be obtained via email by contacting trafficorders@rbkc.gov.uk.
6. The Council will be considering in due course whether the provisions of the Orders should be continued indefinitely by means of Orders made under sections 6 and 45 of the Road Traffic Regulation Act 1984. Any person may object to the making of these Orders for the purpose of such indefinite continuation within a period of six months beginning with the day on which the Orders come into operation, or, if either of the Orders is varied by another Order or modified pursuant to section 10(2) of the 1984 Act, beginning with the day on which the variation or modification or the latest variation or modification came into operation. Any such objection must be in writing and must state the grounds on which it is made and be sent to Traffic Orders, Room 308, Council Offices, The Royal Borough of Kensington and Chelsea, 37 Pembroke Road, London, W8 6PW or email: trafficorders@rbkc.gov.uk, quoting reference RBKC/TMO/Basil Street ETO by **15th March 2021**.
7. Under the Local Government (Access to Information) Act 1985, any letter you write in response to this Notice may be made available to the press and to the public, who would be entitled to take copies of it if they so wished.
8. If any person wishes to question the validity of the Orders or of any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders were made, apply for the purpose to the High Court.
