

## ROYAL BOROUGH OF KENSINGTON AND CHELSEA

### CONSOLIDATION OF PEDESTRIAN AND CYCLE ZONE ORDERS

#### *The Kensington and Chelsea (Prescribed Routes) (No. X) Traffic Order 2024*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea (hereinafter referred to as “the Council”) propose to make the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order would be to:
  - (a) combine into a single Traffic Order the existing pedestrian and cycle zones within the Royal Borough of Kensington and Chelsea along with an existing vehicle ban in parts of Portobello Road; and
  - (b) remove the exceptions and exemptions to the restrictions referred to in sub-paragraph (a) above that currently apply to disabled persons blue badge holders, these being as follows:
    - (i) the signed exception that applies to the pedestrian and cycle zones in Bute Street and Portobello Road; and
    - (ii) the exemption that applies to the Council’s existing school street pedestrian and cycle zones.

These changes will **NOT** affect access into each street.
