1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea (hereinafter referred to as "the Council") propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Orders would be:-
 - (a) on the south-west side of **Egerton Terrace**, to convert 4.5 metres (15ft) of residents' parking outside the flank wall of No. 227 Brompton Road, situated in Egerton Terrace, to a dockless bicycle bay;
 - (b) in the carriageway on **Exhibition Road**, in line with, and south of, the Santander cycles docking station of Exhibition Road, to introduce a 5 metre (16ft) long dockless bicycle bay immediately north of the junction with Cromwell Road/Cromwell Gardens;
 - (c) on the south-west side of **Halsey Street** to convert an echelon residents' parking bay outside the flank wall of No. 18 Milner Street, situated in Halsey Street, to an echelon dockless bicycle bay;
