**EARDLEY CRESCENT, EARL'S COURT SQUARE AND KEMPSFORD GARDENS PARKING CONTROLS  
DURING EVENTS IN THE EARL'S COURT AREA**

**The Kensington and Chelsea (Charged-For Parking Places) (Amendment No. \*\*) Order 2022**

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea (hereinafter referred to as "the Council") propose to make the above-mentioned Order under section 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Order would be, on days during which an event is being held at the site of the former Earl's Court Exhibition Centre that the Council deem would adversely affect residents' ability to park in nearby streets:

- (a) to extend the hours of operation of the residents' parking places in Eardley Crescent, Earl's Court Square and Kempsford Gardens to include the hours between 6.30pm and 10pm on Saturdays and between 8.30am and 10pm on Sundays. This would mean that the hours of operation of those parking places on those days would be between 8.30am and 10pm; and
- (b) to provide that visitors to residents of Eardley Crescent, Earl's Court Square and Kempsford Gardens whose vehicle details have been registered with the Council for the purpose of parking in the residents' parking places in those roads, would be permitted to park in those residents' parking places between 6.30pm and 10pm on Saturdays and between 8.30am and 10pm on Sundays.
