**PROPOSED CHANGES TO CERTAIN OFF-STREET RBKC HOUSING PARKING BAY PROVISIONS IN THE HORTENSIA HOUSE, PORTOBELLO COURT, 69 ST QUINTIN AVENUE AND TAVISTOCK CRESCENT ESTATES**

*The Kensington and Chelsea (Housing Estates) (Off-Street Parking Places and Waiting and Loading Restrictions) (Amendment No. \*) Order 2023*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea propose to make the above-mentioned Order under sections 35 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the general effect of which would be in respect of the following off-street housing estates to:–

- (a) **Hortensia House Estate** - convert RBKC Housing resident permit holders parking bay (number 10) to RBKC Housing disabled bay HOH 02;
- (b) **Portobello Court Estate** - convert RBKC Housing resident permit holders parking bay (number 2) to RBKC Housing disabled bay PBC 02;
- (c) **69 St Quintin Avenue Estate** - convert RBKC Housing resident permit holders parking bay (number 1) to a RBKC Housing visitors bay;
- (d) **Tavistock Crescent Estate** - convert RBKC Housing resident permit holders parking bay (number 18) to RBKC Housing disabled bay TSC 05;
