- xvii. on the north-west side of **Pitt Street**, outside the flank wall of No. 18 Gordon Place, situated in Pitt Street, for 10 metres (33ft);
- xviii. on the north side of **St Quintin Avenue**, opposite No. 41 St Quintin Avenue, for 2.5 metres (8ft);
- xix. on the west side of **Sirdar Road**, at the northern entrance to Henry Dickens Court, for a total of 4.5 metres (15ft);
- on the south side of Victoria Gardens, at the southernmost end of Victoria Gardens. This is the section of single yellow line which stretches along the bollards outside No. 7 across to No. 16 Victoria Gardens, for 6 metres (20ft);
- xxi. on the south-west side of **Wallingford Avenue**, outside the flank wall of No. 37 St Quintin Avenue, situated in Wallingford Avenue, for 10.5 metres (34ft);
- xxii. on the north-west side of **Walton Street**, outside No. 40 Walton Street, for 1.5 metres (5ft). The existing loading restriction is not affected;

- (cccc) to update certain Articles and Schedules in The Kensington and Chelsea (Charged-For Parking Places) Consolidation Order 2023 and The Kensington and Chelsea (Free Parking Places, Loading Bays and Waiting, Loading and Stopping Restrictions) Consolidation Order 2023 to accurately reflect the provisions as they currently operate; and
- (dddd) to modify the traffic order definitions of certain other parking places and waiting restrictions so they better reflect what is currently on the ground (there would be no change to the way these restrictions and parking places currently operate on-street).
