- xvi. on the south-west side of **Victoria Grove**, outside No. 36 Gloucester Road, located in Victoria Grove, to No. 5 Victoria Grove, for 34 metres (112ft);
- (qqq) to update certain Articles and Schedules in The Kensington and Chelsea (Charged-For Parking Places) Consolidation Order 2023 and The Kensington and Chelsea (Free Parking Places, Loading Bays and Waiting, Loading and Stopping Restrictions) Consolidation Order 2023 to accurately reflect the provisions as they currently operate; and
- (rrr) to modify the traffic order definitions of certain other parking places and waiting restrictions so they better reflect what is currently on the ground (there would be no change to the way these restrictions and parking places currently operate on-street).
