CHANGES TO CERTAIN OFF-STREET RBKC HOUSING PARKING BAY PROVISIONS IN
THE 375 PORTOBELLO ROAD, ELM PARK GARDENS CENTRAL, HENRY DICKENS COURT, KNIGHT'S
HOUSE, LONGLANDS COURT AND TAVISTOCK CRESCENT ESTATES

*The Kensington and Chelsea (Housing Estates) (Off-Street Parking Places and Waiting and Loading Restrictions)
(Amendment No. 7) Order 2023*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea on 24th August 2023 have made the above-mentioned Order under sections 35 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the general effect of which will be in respect of the following off-street housing estates to—

- (a) **375 Portobello Road Estate** - convert RBKC-Housing residents' (PBR) parking bay (No. 3) to RBKC-Housing disabled bay (PBR 03);
- (b) **Elm Park Gardens Central Estate** - convert RBKC-Housing visitor (VIS) parking bay (No. 9) to RBKC-Housing disabled bay (EPC 09);
- (c) **Henry Dickens Court Estate** - convert RBKC-Housing residents' (HDC) parking bay (No. 41) to RBKC-Housing visitors' parking bay;
- (d) **Henry Dickens Court Estate** - convert hatched markings, adjacent to bay No. 45, to RBKC-Housing disabled bay (HDC 18);
- (e) **Knight's House Estate** - to move the RBKC-Housing residents' (KTH) parking bay (No. 2) northwards by 3 metres (10ft);
- (f) **Longlands Court Estate** - convert RBKC-Housing motorcycle parking bay (No. 25) to RBKC-Housing visitor (VIS) parking;
- (g) **Longlands Court Estate** - convert 1 metre (3ft) of RBKC-Housing residents' (LLC) parking bay (No. 10) to RBKC-Housing motorcycle parking bay;
- (h) **Tavistock Crescent Estate** - convert RBKC-Housing residents' (TSC) parking bays (Nos. 16 and 17) to RBKC-Housing visitor (VIS) parking bays;
- (i) **Tavistock Crescent Estate** - convert RBKC-Housing visitor (VIS) parking bays (Nos. 32 and 33) to RBKC-Housing residents' (TSC) parking bays; and
- (j) **Tavistock Crescent Estate** - to convert RBKC-Housing residents' (TSC) parking bay (No. 21) to RBKC-Housing disabled bay (TSC 05).

2. A copy of the Order, which will come into force on 31st August 2023 and of all other relevant documents can be obtained for inspection by emailing trafficorders@rbkc.gov.uk, quoting reference: "Housing Amend 7" and can be inspected at The Council Offices, The Royal Borough of Kensington and Chelsea, 37 Pembroke Road, London, W8 6PW between 9am and 5pm on Mondays to Fridays inclusive until the end of a period of six weeks from the date the Order was made.

3. Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Order was made, apply for the purpose to the High Court.
