PROPOSED CHANGES TO CERTAIN OFF-STREET RBKC HOUSING PARKING BAY PROVISIONS IN THE CONVENT HOUSING ESTATE, KNIGHT'S HOUSE HOUSING ESTATE, PORTOBELLO COURT HOUSING ESTATE AND 375 PORTOBELLO ROAD HOUSING ESTATE

*The Kensington and Chelsea (Housing Estates) (Off-Street Parking Places and Waiting and Loading Restrictions) (Amendment No. *) Order 2026*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea (hereinafter referred to as "the council") propose to make the above-mentioned Order under sections 35 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.
2. The general effect of which would be in respect of the following off-street housing estates:-
 - (a) **Convent Housing Estate** – to convert RBKC-Housing personalised disabled permit parking bay (CON 02) to RBKC-Housing permit holders (CON) parking bay (parking bay no. 5);
 - (b) **Convent Housing Estate** – to convert RBKC-Housing permit holders (CON) parking bay (parking bay no. 7) to RBKC-Housing personalised disabled permit parking bay (CON 02);
 - (c) **Knight's House Housing Estate** – to convert RBKC-Housing permit holders (KTH) parking bay (parking bay no. 1) to RBKC-Housing personalised disabled permit parking bay (KTH 01);
 - (d) **Portobello Court Housing Estate** – to convert RBKC-Housing permit holders (VIS) parking bay (parking bay no. 4) to RBKC-Housing personalised disabled permit parking bay (PBC 05);
 - (e) **Portobello Court Housing Estate** – to convert RBKC-Housing permit holders (PBC) parking bay (parking bay No. 9) to RBKC-Housing personalised disabled permit parking bay (PBC 06);
 - (f) **375 Portobello Road Housing Estate** – to convert RBKC-Housing personalised disabled permit parking bay (PBR 01) to RBKC-Housing permit holders (PBR) parking bay (parking bay No. 9); and
 - (g) **375 Portobello Road Housing Estate** – to convert RBKC-Housing permit holders (PBR) parking bay (parking bay No. 8) to RBKC-Housing personalised disabled permit parking bay (PBR 01).
3.
