The Kensington and Chelsea (Free Parking Places, Loading Bays and Waiting, Loading and Stopping Restrictions) (Amendment No. 22) Order 2021 and The Kensington and Chelsea (Charged-For Parking Places) (Amendment No. 24) Order 2021.

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea (hereinafter referred to as "the Council") on 15th April 2021 have made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Orders will be:-
 - (a) on the south-west side of **Allen Street**, to convert 1.5 metres (5ft) of single yellow line (hours of control Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm) outside No.1 Alma Terrace, situated in Allen Street, to residents' parking;
 - (b) at the eastern corner of **Blithfield Street** and **Stratford Road**, to remove daytime loading restrictions (No loading Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm) for a distance of 10 metres (33ft) from the traffic order. There will be no changes to the current on-street restriction;
 - (c) at the western corner of **Blithfield Street** and **Stratford Road**, to remove daytime loading restrictions (No loading Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm) for a distance of 10 metres (33ft) from the traffic order. There will be no changes to the current on-street restriction;
 - (d) on the north-west side of **Bonchurch Road**, to convert 8 metres (26ft) of residents' parking outside Nos. 32 and 34 Bonchurch Road to an at all times Loading Bay (max. stay 40 minutes, no return within 2 hours);
 - (e) on the north-west side of **Bonchurch Road**, to convert 5 metres (16ft) of double yellow line opposite the flank wall of No. 330 Portobello Road, situated in Bonchurch Road, between a point 13m (42ft) from the junction with Portobello Road and 18 metres (56ft) from the junction with Portobello Road to residents' parking;
 - (f) on the north-west side of **Bonchurch Road**, to convert 5 metres (16ft) of double yellow lines opposite the flank wall of No. 330 Portobello Road, situated in Bonchurch Road, between a point 8 metres (26ft) from the junction with Portobello Road and 13 metres (42ft) from the junction with Portobello Road, to single yellow line (hours of control Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm);
 - (g) on the south-east side of the northern arm of **Bramham Gardens**, to convert 3 metres (10ft) of residents' parking, next to the adjacent Car Club Bay, outside the flank wall of no. 27 Bramham Gardens to double yellow lines. This area will accommodate an on-street cycle hangar unit;
 - (h) on the south-west side of the south-western arm of **Earl's Court Square**, to convert 3 metres (10ft) of residents' parking outside the flank wall of No. 51 Earl's Court Square to double yellow lines. This area will accommodate an on-street cycle hangar unit;
 - (i) on the north side of **Edge Street**, to convert 3 metres (10ft) of single yellow line (hours of control Monday to Friday 8.30am to 6.30pm and Sat 8.30am to 1.30pm) outside the flank of No. 145 Kensington Church Street, situated in Edge Street, to double yellow lines. This area will accommodate an on-street cycle hangar unit;

- (m) on the north side of **Elystan Place**, to convert 10 metres (33ft) of residents' parking outside the flank wall of No. 1 Sloane Avenue situated in Elystan Place, to two Pay On-Street visitors' parking bays (hours of control Monday to Saturday 8.30am to 6.30pm, max. stay 2 hours);
- (n) on the north-east side of **Exmoor Street**, to convert one Pay On-Street bay (hours of control Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm, max. stay 10 hours) opposite the flank wall of No. 160 Barlby Road to 5 metres (16 ft) of Visitor Solo Motorcycle Bay (hours of control Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm);
- (o) on the north-east side of **Exmoor Street**, to convert 5 metres (16ft) of residents' parking outside Nos. 25-30 Balfour House, on Exmoor Street to one Pay On-Street bay (hours of control Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm, max. stay 10 hours);
- (p) on the western corner of **Hasker Street** and **Milner Street** to introduce 14 metres (46ft) of 'at any time' loading restrictions, outside Nos. 5 and 7 Milner Street and Hasker Street (for a distance of 2 metres (7ft) along Hasker Street);
- (q) on the north-west side of **Hewer Street**, to convert 5 metres (16 ft) of Visitor Solo Motorcycle Bay (hours of control Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm) outside No. 7 Hewer Street to residents' parking;
- (r) on the north-east side of **Hillsleigh Road**, to convert 6 metres (20ft) of double yellow lines opposite No. 8 Hillsleigh Road, to residents' parking;
- (s) on the south-east side of **Holland Park Road**, to convert Car Club bay (KC-038) outside the flank wall of Nos. 1-33 Abbot's House, situated in Holland Park Road, to an Electric Vehicle charging bay;
- (t) on the south-east side of **Holland Park Road**, to convert a Pay On-Street visitors' parking bay (hours of control Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm, max. stay 4 hours) outside the flank wall of Nos. 1-33 Abbot's House, situated in Holland Park Road, to an Electric Vehicle charging bay;
- (u) on the south-east side of **Holland Park Road**, to convert to convert a diplomatic parking bay outside the flank wall of Nos. 1-33 Abbot's House, situated in Holland Park Road, to a Pay On-Street visitors' parking bay (hours of control Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm, max. stay 4 hours);

- (aaaa) on the west side of **Sloane Street**, to convert single yellow line (hours of control Monday to Saturday 8am to 6.30pm) to double yellow lines and conversion of no loading restrictions Monday to Friday 8am to 9.30am to no loading Monday to Saturday 8.30am to 10am and 4pm to 6.30pm for a distance of 23 metres (75ft) outside Nos. 131 to 135 Sloane Street;
- (bbbb) on the west side of **Sloane Street**, to reduce the single yellow line hours of control from Monday to Saturday 8am to 6.30pm to Monday to Saturday 8.30am to 6.30pm and remove the restrictions on loading Monday to Friday 8am to 9.30am for a distance of 7 metres (23ft) outside No. 135 Sloane Street;
- (cccc) on the west side of **Sloane Street**, to convert single yellow line (hours of control Monday to Saturday 8am to 6.30pm) to double yellow lines and conversion of no loading restrictions Monday to Friday 8am to 9.30am to no loading Monday to Saturday 8.30am to 10am and 4pm to 6.30pm for a distance of 4 metres (13ft) outside No. 136 Sloane Street;
- (dddd) on the north side of **Sloane Terrace**, to convert no loading restrictions Monday to Friday 4.30pm to 6.30pm to no loading Monday to Saturday 8.30am to 10am and 4pm to 6.30pm for a distance of 11 metres (36ft) outside the flank of No. 150 Sloane Street, situated in Sloane Terrace;
- (eeee) on the north-west side of **Stoneleigh Place**, to convert 3 metres (10ft) of residents' parking outside the flank wall of No. 50 Stoneleigh Street, situated in Stoneleigh Place, to double yellow lines. This area will accommodate an on-street cycle hangar unit;
- (ffff) on the south-west side of **Tetcott Road**, to convert 3 metres (10ft) of single yellow line (hours of control Monday to Saturday 8.30am to 6.30pm) opposite No. 35 Tetcott Road to double yellow lines. This area will accommodate an on-street cycle hangar unit;
- (gggg) on the north-east side of **Wright's Lane**, to convert 1.65 metres (5ft) of Pay On-Street visitors' parking bay (Monday to Saturday 8.30am to 6.30pm, max stay 2 hours) outside No. 15 Wright's Lane (from a point 16.2 metres south of the Disabled Blue Badge bays, to a point 17.85 metres south of the Disabled Blue Badge bays) to double yellow lines;
- (hhhh) on the north-east side of **Wright's Lane**, to redistribute the nine Pay On-Street visitors' parking bays, outside No. 15 and No. 27 Wright's Lane, retaining the same number of bays, but leaving each slightly smaller to accommodate the total loss of 1.65 metres (5.3ft) of Pay On-Street parking space detailed immediately above; and
- (iiii) to convert single yellow line waiting restriction situated at the following locations to double yellow lines waiting restrictions:
- i. on the western corner of the **Blenheim Crescent** and **St. Mark's Place** junction for a distance of 9.5 metres (31ft);
 - ii. on the eastern corner of the **Blenheim Crescent** and **St. Mark's Place** junction for a distance of 11 metres (36ft);
 - iii. on the west side of the western arm of **Brompton Square**, for a distance of 8 metres (26ft) outside No. 27 Brompton Square. The double yellow lines will still allow loading/unloading to take place;

- iv. on the east and south sides of the eastern and northern arms of **Brompton Square**, for a distance of 8 metres (26ft) opposite No. 27 Brompton Square. The double yellow lines will still allow loading/unloading to take place;
 - v. on the northern corner of the junction of **Ladbroke Grove** and **St John's Gardens**, for a distance of 15 metres (49ft);
 - vi. on the southern corner of the junction **Ladbroke Grove** and **St John's Gardens**, for a distance of 9.5 metres (31ft);
 - vii. on the south-west side of **Oakley Street**, for a distance of 10 metres outside the vehicular entrances of Adair House and Pier House, on Oakley Street;
 - viii. on the north-east side of **Ovington Gardens**, for a distance of 7 metres (23ft) outside the flank wall of 193-195 Brompton Road, situated in Ovington Gardens. The double yellow lines will still allow loading/unloading to take place;
 - ix. on the north-east side of **Ovington Gardens**, for a distance of 10 metres (33ft) outside No. 11 Ovington Gardens. The double yellow lines will still allow loading/unloading to take place;
 - x. on the corner of the junction of **Ovington Gardens** and **Ovington Square**, for a distance of 10 metres (33ft) outside No. 1 Ovington Gardens, and its flank wall situated in Ovington Square. The double yellow lines will still allow loading/unloading to take place;
 - xi. on the north-east side of **Ovington Square**, for a distance of 7.5 metres (25ft) opposite No. 43 Ovington Square. The double yellow lines will still allow loading/unloading to take place;
 - xii. on the north-west side of the south-eastern arm of **Redcliffe Square**, for a distance of 8.5 metres (28ft) outside the entrance to St. Luke's Church, opposite Nos. 41 and 43 Redcliffe Square;
 - xiii. on the south side of **Vicarage Gate**, for a distance of 7 metres (23ft) outside the entrance to Hamilton House, in Vicarage Gate; and
- (jjj) to modify the traffic order definitions of certain other parking places and waiting restrictions so they better reflect what is currently on the ground (there will be no change to the way restrictions and parking places currently operate).
3. Copies of the Orders, which will come into operation on 22nd April 2021 and of all other relevant documents can be obtained for inspection until the end of a period of six weeks from the date the Orders were made via email by emailing trafficorders@rbkc.gov.uk, quoting reference: Feb Misc 2021.
4. Anyone wishing to question the validity of the Orders or of any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders were made, apply for the purpose to the High Court.
