The Kensington and Chelsea (Housing Estates) (Off-Street Parking Places and Waiting and Loading Restrictions) (Amendment No. *) Order 2022

- 1.  - (b) **Henry Dickens Court Estate** convert RBKC Housing resident permit holders parking bay (number 4), to RBKC Housing disabled bay HDC-17;
 - (c) **Henry Dickens Court Estate** convert RBKC Housing visitor permit holders parking bay (number 46) to hatched markings;
 - (d) **Henry Dickens Court Estate** convert RBKC Housing disabled bay HDC 09 (parking bay number 19) to RBKC Housing disabled bay HDC 10;
 - (e) **Henry Dickens Court Estate** convert RBKC Housing disabled bay HDC 10 (parking bay number 20) to RBKC Housing disabled bay HDC 09;
 - (f) **Henry Dickens Court Estate** convert RBKC Housing disabled bay HDC 07 to RBKC Housing resident permit holders parking bay (number 23); and
 - (g) **Henry Dickens Court Estate** convert RBKC Housing resident permit holders parking bay (number 25) to RBKC Housing disabled bay HDC 07.
