

## ROYAL BOROUGH OF KENSINGTON AND CHELSEA

### EXPERIMENTAL PEDESTRIAN AND CYCLE ZONE IN ST CHARLES SQUARE OUTSIDE ALL SAINTS CATHOLIC COLLEGE AT DROP-OFF AND PICK-UP TIMES

*The Kensington and Chelsea (Prescribed Routes) (No. 4) Experimental Traffic Order 2021*

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kensington and Chelsea on 26<sup>th</sup> March 2021 made the above-mentioned Order under sections 9 and 10 of the Road Traffic Regulation Act 1984, as amended. The Order will come into operation on 19<sup>th</sup> April 2021 and continue in force for up to 18 months.

2. The general effect of the Order will be on an experimental basis to provide a pedestrian and cycle zone in St Charles Square (outside All Saints Catholic College). Motor vehicles will be banned from entering St Charles Square (north to south arm) between the south-eastern kerb-line of St Charles Square (arm adjacent to Nos. 26 and 28 St Charles Square and Nos. 273 and 275 Ladbroke Grove) and the north-western kerb-line of St Charles Square (southernmost west to east arm) between 8.00 a.m and 8.30 a.m. and between 2.45 p.m. and 3.15 p.m. on Mondays to Fridays inclusive (term time only).

[Note: Foot scooters, electric scooters, emergency vehicles, Dial-a-ride buses and vehicles displaying a valid Blue Badge are exempt from the closure. Residents and traders who live or work in the sections of road referred to above will be able to register for an exemption.]

3. The Order provides that in pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Director for Streets and Regulatory Services at the Council of the Royal Borough of Kensington and Chelsea, or some person authorised by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Order extends, modify or suspend the Order or any provision thereof.

6. The Council will be considering in due course whether the provisions of the Order should be continued indefinitely by means of an Order made under section 6 of the Road Traffic Regulation Act 1984. Any person may object to the making of this Order for the purpose of such indefinite continuation within a period of six months beginning with the day on which the Order comes into operation, or, if the Order is varied by another Order or modified pursuant to section 10(2) of the 1984 Act, beginning with the day on which the variation or modification or the latest variation or modification came into operation. Any such objection must be in writing and must state the grounds on which it is made and be emailed to [trafficorders@rbkc.gov.uk](mailto:trafficorders@rbkc.gov.uk) or posted to Traffic Orders, Room 308, Council Offices, The Royal Borough of Kensington and Chelsea, 37 Pembroke Road, London, W8 6PW, quoting reference RBKC/TMO/All Saints School by **19<sup>th</sup> October 2021**.

7. Under the Local Government (Access to Information) Act 1985, any letter you write in response to this Notice may be made available to the press and to the public, who would be entitled to take copies of it if they so wished.

8. Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within six weeks from the date on which the Order was made, apply for the purpose to the High Court.
